



Announcement of the selection procedure of a candidate for the position of Dean of the Faculty of Dramatic Arts at the Academy of Arts in Banska Bystrica

The Academy of Arts in Banska Bystrica (hereinafter referred to as „the Academy of Arts“) pursuant to Section 22 (3) of the Act No. 131/2002 Coll. on Higher Education and on Amendments and Additions to Certain Acts as amended, Article 33 (9) of the Statute of the Academy of Arts in Banska Bystrica and in accordance with the Principles of the Selection procedures for filling positions of university teachers, research and artistic staff, positions of professors and associate professors, and functions of senior employees and deans of faculties (hereinafter referred to as „the Principles“), hereby

Preconditions for participation in the selection procedure:

- full legal capacity
- clean criminal record
- qualification prerequisites: second-cycle university education
- managing skills

Required documents:

- application for participation in the selection procedure, including consent to the processing of personal data pursuant to the Act No. 18/2018 Coll. on personal data protection (written consent)
- professional resume (written consent)
- documents proving the achieved education and scientific and pedagogical degrees (these documents do not need to be submitted by a candidate who held the position of Dean prior to the announcement of the selection procedure or if the required documents are already part of the candidate's personal file)
- overview of previous experience
- signed affidavit of a clean criminal record, signed affidavit of full legal capacity, signed affidavit of truthfulness of the data provided in the required documents (written consent)
- written development strategy of the Faculty of Dramatic Arts for the time period 2024 - 2028 – in line with the Long-Term plan of the Academy of Arts in Banska Bystrica for the time period 2021 – 2026, the Long-Term plan of the Faculty of Dramatic Arts of the Academy of Arts in for the time period 2021 – 2026, and the measurable indicators of performance contracts of the Academy of Arts for the years 2025 and 2026 (written consent, max. 18,000 characters)

Written development strategy of the Faculty of Dramatic Arts should address the following areas in detail:

- Artistic higher education
 - sustainability, development, and optimization of study programs
 - linking study programs with practice
- Science, research, and artistic activities
 - performance optimization



- grant acquisition and support
- Faculty financing and management
 - social climate and interpersonal relationships
 - acquisition of extrabudgetary resources
 - entrepreneurial activities
- Communication, promotion, and relations with the external environment
- Other areas at your discretion

Term of Office:

- the selection procedure is announced for a four-year term of office with the expected commencement of duties on 1. 12. 2024

Application for participation in the selection procedure for the position of dean must be submitted together with the required documents no later than the 60 days from the announcement of the selection procedure in sealed enveloped marked "VK na dekana FDU – NEOTVÁRAŤ" to Academy of Arts in Banska Bystrica, The office of the rector, Kollárova 22, 974 01 Banska Bystrica.

The Selection Committee for the selection procedure to fill the position of dean consists of seven members. Part of the selection procedure for the position of dean involves a public hearing of the candidates.

The Dean is appointed to the position by the Rector based on the selection procedure. The Rector, upon appointing the Dean, enters into a contract of service with the Dean for the duration of the term of office. This contract includes measurable indicators aimed at improving the quality of higher education provided by the faculty and the level of research, development, or artistic and other creative activities of the faculty, as well as goals derived from the long-term plan of the Academy of Arts.
